Welcome!

This brochure provides details of Bromley Safeguarding Children Partnership (BSCP) courses for 2021-22 designed to assist agencies to meet their responsibilities in respect of safeguarding children.

Audiences for our training include the whole of the children and young people's workforce in Bromley and those working with adults who are parents or carers (for example, adult psychiatrists and probation staff). It includes paid staff and volunteers working in the statutory, voluntary, community and independent sectors.

Training together can make a significant contribution to a shared understanding of roles and responsibilities, enhancing communication between professionals and others working with children and families, as well as improving effective working together based on sound relationships.

The BSCP depends on everyone, whether professionals or volunteers, parents or members of the public having an understanding of their own personal or professional responsibility to safeguard children and being alert and active in carrying this out. The priorities are set out in the BSCP Pledge which is available at www.bromleysafeguarding.org.

Each agency in Bromley is responsible for ensuring that their staff are competent and confident in carrying out their responsibilities for safeguarding and promoting children's welfare. This includes ensuring staff have access to appropriate training and that the training is regularly updated at least every three years.

The BSCP monitors and evaluates the effectiveness of training, including multi-agency training, to safeguard and promote the welfare of children. In Bromley, this responsibility is devolved to the BSCP Training Subgroup which is accountable to the BSCP's main board.

The Training Subgroup monitors the uptake of training and regularly evaluates the BSCP training offer to ensure that it addresses local need and emerging local and national issues. We do this in a number of ways. Everybody attending one of our courses will be asked to complete an evaluation at the end of the session rating their experience of the content, the trainer and the learning environment. The BSCP will also send out a 2 month post evaluation form to the attendee and (informing his/her manager) for feedback on what has been learnt and applied in practice in the workplace. The manager will be asked to send an explanation in writing if this is not completed for our records.

At the time of publication, all our training courses are being delivered online.

Information for Course Participants

Before you book a BSCP course

A **prerequisite** for attending any of our training is that participants have received basic single-agency child protection training through their own agencies/or previous employment. If you have not received basic training you need to contact your agency's Safeguarding Team. If it is not offered by your agency, you should complete the Me Learning Safeguarding Children online learning modules, details below.

Applying for BSCP Courses

Before applying for a course, you need to ensure that you have checked the course aim, learning outcome, target audience, and any entrance requirements/pre-requisites, in order to ascertain whether the course is appropriate for you. There are various levels of training need across our partnership. Please see pages 7- 8 'Training that meets learning needs' (groups/levels). This will offer some guidance on what courses are best for you.

You also need to talk it through with your manager and if they agree, then book a place via Evolve, our new Learning Management System. You will need to register for an account, once only. Please follow the instructions in the [Evolve User Guidance](#). **This User Guidance explains all you need to know about Evolve.**



Remember, you cannot book a place until you have ticked two boxes – confirmation that you have completed any pre-requisite, and agreement to the terms and conditions.

If a course is full, you can join the waiting list via Evolve. If there are no dates set yet, you can 'declare an interest' for the course via Evolve, to ensure you receive notification as soon as a date is set. The Evolve website is <https://evolve.bromley.gov.uk/>

Our courses are filled on a first-come, first serve basis, whilst ensuring that there is a good mix of agencies.

Once you have secured a place via Evolve you will receive confirmation and information about any pre-course reading via email. Evolve is a self-service platform and you can make changes, cancel your place, complete the post-course evaluations and print your own certificate of attendance.

If your confirmation email does not come through, check your junkmail/ spam.

Accessibility

When we are not in a global pandemic, training is usually provided at the Civic Centre, Stockwell Close, Bromley BR1 3UH (unless otherwise stated). Please notify Workforce Development 020 8313 4910 if you have any special requirements.

Attendees with communication needs or a disability are asked to make Bromley Workforce Development aware if additional equipment or a person from your agency may be accompanying you in a support capacity.

During the COVID pandemic, all classroom-based training has been replaced with online webinars. These are usually on MS Teams or Zoom. We occasionally use WebEx.

Who pays for courses?

Courses are **free** to staff working in agencies in Bromley that have contributed financially to the BSCP . These are staff from:

- London Borough of Bromley (LBB)
- Oxleas NHS Foundation Trust
- Bromley Healthcare (BHC)
- NHS SEL Clinical Commissioning Group (CCG)
- King's College Hospital NHS Foundation Trust (KCH)
- South London and Maudsley NHS Trust (SLAM)
- Metropolitan Police (MPS)
- London Fire Brigade (LFB)
- London Probation (National Probation Service and Community Rehabilitation Company staff working with Bromley residents)

Staff and **volunteers** working for local Bromley organisations, charities and groups which have an annual turnover of under £500k will not be charged for any BSCP courses.

The following courses are free to all, regardless of agency: CAF, domestic violence/abuse, Prevent, Private Fostering Awareness, Use of Chronologies and the LADO's Managing Allegations training. Where we can secure free training from a provider, we will not charge you.

For all other agencies including, private organisations, companies, consultancies, schools and colleges, large charities/voluntary organisations with a turnover of over £500k pa , there is a cost for training, where we have paid an external trainer. Usually the cost for live classroom based training is £250.00 per two day course, £150.00 per day course and £90 for a half day course. **During the pandemic where courses are online and shorter, the charges are usually: £150 for the two day DSL course; £90 for one day (usually condensed to three or four hours). However, this may vary depending on the course so please check flyers/Evolve.**

- Significant discounts are available to registered early years providers such as nurseries, pre-schools and childminders. Courses cost £50 for a half-day/day course, £100 for a two day course
- There is a 10% discount for Bromley LA maintained schools

Cancellations and No Show Fees

Since 2017, there has been a late cancellation/no show fee applied to all of our courses, even if you have received the place for free. This is because the BSCP has incurred costs for your place. Since introducing a cancellation/no show fee, we have seen a huge rise in attendance (to 89%) therefore we have continued with this policy. However, for 2021-22 only BSCP is suspending charges where a participant is unable to access the webinar on the day due to technical difficulties during the COVID pandemic. If the no show rate rises, we reserve the right to reintroduce the fee this year.

It is essential that you inform Workforce Development if you are unable to attend. **Two working days' notice** is required. Cancellations **must** be confirmed by you in writing (e.g. email). This enables us to offer a place to someone on the waiting list. If you booked on Evolve, you can cancel your place yourself.

Certification and Evaluation of Training

A Certificate of Attendance will only be issued to participants who are **present for the entire course** and who have completed the two post training evaluations. In face to face training sessions, candidates must sign the register, as without this, the attendance certificate cannot be issued. Trainers will not allow you to join the course if you arrive late and they have begun the training.

The Evolve system will send out a link to the two short evaluations – one short questionnaire immediately after the course, and another 2 month post evaluation form to the attendee for feedback on what has been learnt and applied in practice in the workplace. The manager will be asked to send an explanation in writing if this is not completed for our records.

Attendees can print off their own certificate from Evolve once the two evaluations are completed. This should be kept with your own CPD evidence.

BSCP may contact you six months after training as part of a randomly selected sample to check what impact training is having on local practice and whether it is improving outcomes for the children and families we work with.

Competence Still Matters

The London Safeguarding Children Board produced guidance for agencies in 2014 on safeguarding training for employees and volunteers setting out responsibilities for all organisations in Competence Still Matters: safeguarding training for all employees & volunteers a guide to the responsibilities of all agencies.

The framework has been designed to assist all employers, voluntary organisations and LSCPs to meet the minimum requirements for the provision of safeguarding children training. It provides a framework for single and multi-agency training to enable professionals, volunteers, agencies, organisations and services to acquire the skills and knowledge to work effectively. It promotes consistency across the London boroughs for the delivery of such training whilst allowing for the degree of flexibility required to meet locally identified needs. Whilst the implementation of Competence Still Matters is not mandatory, it represents a standard of good practice and helps BSCP and our partner organisations fulfil our responsibilities as outlined in Working Together to Safeguard Children.

Training Levels

What training courses best meet your learning needs?

BSCP has developed its training courses to be tailored to meet your professional workplace needs based on the amount and nature of your working involvement with children and young people. Every training course advertised stipulates which group (1-8) it is suitable for to ensure that you are able to identify a course to meet your work needs. This is in line with Competence Still Matters. We have also labelled these BASIC, INTERMEDIATE and ADVANCED for ease.

The following groups are provided for:

BASIC TRAINING

Group 1- Staff in infrequent contact with children, young people and/or parents/carers who may become aware of possible abuse or neglect.

- **Examples of Jobs:** If you are a librarian, GP receptionist, a community advice centre staff, a parks & premises staff, a recreation assistant, an environmental health officers or any other similarly involved professional then a course graded level 1 will meet your needs
- **Content of Courses:** The courses will tend to focus on Basic Child Protection: child abuse and neglect, signs and indicators of abuse and neglect and what is normal child development. Most of these courses are delivered by BSCP e-Learning.

Group 2- Staff in regular contact or have a period of intense but irregular contact, with children, young people and/or parents/carers who may be in a position to identify concerns about maltreatment including those that might arise from the use of CAF.

- **Examples of Jobs:** If you are a pre-school and day nursery worker, housing officer, staff member in a hospital, a YOS worker, or secure settings worker, Police officer (not in a specialist child protection role), a sports & leisure development officer, a disability specialist, a member of a faith group, a community youth worker, a play scheme volunteer or any other similarly involved professional then a course graded level 2 will meet your needs

- **Content of Courses:** The courses will tend to focus on Basic Child Protection, Information Sharing , effective multi-agency working , and models for the assessment of children's welfare and safety needs

INTERMEDIATE TRAINING

Group 3- Staff working predominantly with children, young people and/or their parents/carers and who could contribute to assessing, planning, intervening and reviewing the needs of a child and parenting capacity where there are safeguarding concerns.

- **Examples of Jobs:** If you are a paediatrician, GP, youth worker, early years staff, residential worker, midwife, school nurse, health visitor, sexual health staff, teacher, probation officer, sports welfare officer, workers in a community play scheme, those working with adults in, for example, learning disability, mental health or alcohol and drug misuse services or any other similarly involved professional then a course graded level 3 will meet your needs
- **Content of Courses:** The courses will tend to focus on effective multi-agency working, the impact of parenting issues like domestic abuse, mental health problems and substance misuse, the importance of family history functioning, working with families; the difficulty engaging and superficial compliance with professionals, managing thresholds for need and risk engaging in the child protection process.

ADVANCED TRAINING

Group 4 - Members of the workforce who have particular responsibilities in relation to undertaking section 47 enquiries.

- **Examples of Jobs:** If you are a professional from health, education, police or children's social care; and you work with complex cases or are a social worker with responsibility for coordinating assessments of children in need then a course graded level 4 will meet your needs.
- **Content of Courses:** The courses will tend to focus on Section 47 enquiries & collaborative practice, using professional judgement, taking emergency action, working with complexity of need and risk communicating with children.

Group 5- Professional Advisors, named and designated lead professionals

- **Examples of Jobs:** : Designated Safeguarding Lead (DSL) in a school or early years setting, Named Nurse, Named Doctor, Designated Nurse, Designated Doctor
- **Content of Courses:** The courses will tend to focus on promoting effective professional practice, supervision and advice, managing performance, and other specialist training

Group 6- Operational managers at all levels including: practice supervisors; front line managers and managers of child protection units.

- **Content of Courses:** The courses will tend to focus on promoting effective professional practice, supervision and advice, managing performance, and other specialist training.

SENIOR STRATEGIC STAFF

Group 7- Senior Managers responsible for Strategic management of services for children, young people

Group 8- Members of Local Safeguarding Children Partnership Board including: board members; independent chairs; directors of children's services; elected members; lay members; members of executive and sub/task groups; business support team; inter-agency trainers.

- **Content of Courses:** Specialist training will be commissioned for Groups 7 and 8.

Pathway to BSCP Child Protection Training

STEP 1- BASIC LEVEL-SINGLE AGENCY

Complete the Basic Child Protection Training provided by your own agency.

All work organisations and agencies have a responsibility to provide basic child protection training for appropriate staff.

The **aim** of this training: To recognise and respond appropriately to a 'child in need' and a child at risk of 'significant' harm.

The BSCP has agreed that basic single agency training should cover the following areas:

Content:

- **Signs and symptoms of abuse and neglect**
- **Categories of abuse**
- **Normal child development**
- **Basic safe practice**
- **Key guidance and legislation**
- **How to make a referral**
- **Importance of inter- agency working.**

The **Target Groups** for this training should be staff in infrequent contact with children, young people and/or parents/carers who may become aware of possible abuse or neglect **or** Staff in regular contact or who have a period of intense but irregular contact with children, young people and/or parents/carers who may be in a position to identify concerns about abuse and neglect.

Groups 1 & 2 identified in this BSCP Inter-Agency Training Brochure

If you have any doubts about your suitability for this internal training discuss it with your manager / supervisor who will ultimately need to agree and authorise your attendance.

STEP 2 - INTERMEDIATE LEVEL TRAINING

This could be:

a) Training provided by your own Single Agency to address your child protection responsibilities in relation to particular work you carry out with children

Entrance requirements: Normally completion of your internal basic child protection training and/or the BSCP E Learning Course **or**,

b) Multi-Agency-Safeguarding Children Training provided by the BSCP .-

Entrance Requirements: You will normally need to have completed your internal basic child protection training and the BSCP e-learning basic child protection course. Groups 3 & 4 will also need knowledge of the Framework for the Assessment of Children.

This training is targeted to meet the particular training needs of different groups (see [‘What training courses best meet your learning needs’](#)).

STEP 3 - SPECIALIST LEVEL TRAINING

This could be:

a) Specialised Training provided by your own Single Agency to update or explore in more depth a particular subject/practice area, to enhance knowledge or competence in this area.

Target group and Entrance requirements: to be determined from within your agency **or**,

b) Multi-Agency Specialist Child Protection Courses provided by the BSCP to update or explore in more depth a particular area of child protection to enhance competence and capacity to work together with other agencies.

These Courses are aimed at training Groups from 3 and above. Some are targeted at managers, those with responsibilities for leading or contributing to Section 47 Investigations/ child in need assessments, and named lead/ designated/ professionals.

Please read the published details for each course carefully and discuss the appropriateness of attending a course with your manager/supervisor to ensure that the course you apply for is best suited to your learning needs.

BSCP Multi-Agency Safeguarding E-Courses (online learning)



You can access safeguarding training courses on Me Learning's easy-to-use website – ideal as a refresher or as an induction for new staff and as a supplement to other types of learning.

These courses are aimed at professionals and volunteers who work or have contact with children, young people and their families and/or adults at risk within the London Borough of Bromley

Most courses take between 60 to 90 minutes to complete – but you can dip in and out multiple times and it will remember where you left off. You can log in at work or at home.

Successfully complete the simple quiz at the end of a course to gain your certificate, (you can have more than one go to try to get a higher score!). The best bit is these courses are available **FREE** to all within Bromley.

HOW TO REGISTER

- 1) Make sure you have access to your email before you register
 - 2) Type in this address or click on link:

 - 3) Click on the blue 'self-register' button
 - 4) Enter all of your details, including a username.
 - 5) Enter the correct information in all of the fields using the drop down arrow to select.
 - 6) Click 'Send log-in request'
 - 7) You will then receive a welcome email to your registered email account. Please select the link within the email to confirm your email address. You will then receive another email with your username and temporary password.

BSCP Multi-Agency Safeguarding Courses (live learning)

Group 3 Safeguarding Children: A Multi Agency Approach

DURATION: Half day

TRAINER: Wardell Associates

AIM: To develop knowledge, skills and the ability to work together on the processes for safeguarding and promoting the welfare of children, including those who are suffering, or at risk of suffering, significant harm.

TARGET GROUP 3: Professionals/Staff working predominantly with children, young people and/or their parents/carers and who could contribute to assessing, planning, intervening and reviewing the needs of a child and parenting capacity where there are safeguarding concerns.

Examples: Paediatricians, GPs, youth workers, early years staff, residential staff, midwives, school nurses, health visitors, sexual health staff, teachers, probation staff, sports welfare officers, adult workers learning disability, mental health, alcohol and drug misuse services, community play schemes.

OUTCOMES:

By the end of the training session training participants will be able to:

- Demonstrate knowledge of patterns and indicators of child maltreatment and able to identify indicators of risk and need
- Describe the needs of children and young people from culturally and racially diverse backgrounds
- Describe and contribute to the processes outlined in What To Do If You're Worried A Child Is Being Abused, including the purpose of inter-agency activities and the decisions required at each stage
- Demonstrate skills in effective collaboration between agencies
- Contribute to the assessment model used by agencies at the different levels of intervention i.e. CAF, Child In Need and Child Protection
- Refer to and use the guidance and procedures to be followed, including the ways in which information will be shared across professional boundaries, within and between agencies, and how that information will be recorded
- Specify the precise roles and responsibilities of different interagency professionals involved, including the way in which children and other family members will be involved
- Outline the timescales set down in the regulations and guidance that govern the completion of assessments, making plans and timing of reviews
- Be able to respond appropriately and raise concerns if they are unhappy with the response given by agencies following a referral or if they have further worries about a child

PRE-REQUISITES: Completion of Multi-Agency or Single Agency basic/introduction Safeguarding Training and/or the BSCP E-Learning for levels 1 and 2 (see page 11)

Refresher Training: At least every 3 years

Group 4/5 Safeguarding Children: A Multi Agency Approach

DURATION: Two days

AIM: To enhance knowledge and skills and the ability to work together on the processes for safeguarding and promoting the welfare of children in complex and challenging situations.

TARGET GROUP Professionals with:

- Particular responsibilities in relation to undertaking Section 47 enquiries including professionals from health, education police and children's social care; those who work with complex cases and social work staff responsible for co-ordinating assessments of children in need. Group 4
- Professional advisers, designated, named and lead professionals and those with managerial responsibility at an operational level such as recruitment of staff, supervision and advice, team management and decision making
Group 5

This training aligns with: Level 4 & 5 (Safeguarding Children & Young People: Roles & Competences for Health Care Staff – Intercollegiate Document).

OUTCOMES: By the end of the training session training participants will be able to:

- Demonstrate a highly developed awareness of their own roles and responsibilities, and those of others, in safeguarding and promoting the welfare of children during the assessment, planning, intervention and review processes
- Describe, and be able to advise others on, when and how to share information on a child about whom they have concerns, with due regard to consent and confidentiality
- Describe the factors that may inhibit the recognition of concerns
- Recognise the impact of anxiety on effective inter-agency working
- Demonstrate skills in inter-agency communication and consultation to promote positive outcomes for children and their families in all circumstances, including those where there is a difference of opinion
- Understand any timescales set down in guidance that govern completion of actions pertaining to children
- Demonstrate capacity for analysis and professional judgment through explaining the purpose and rationale for decision making and helping others to analyse and evaluate concerns, information and assessments when contributing to inter-agency judgments and decision making.

PRE-REQUISITES: Multi-Agency or Single Agency Training at Group 3 level.

Refresher Training: At least every 2 Years for Education Establishments Designated Child Protection and Safeguarding staff and 3 years for other agencies.

Group 4/5 Safeguarding Children Refresher: A Multi Agency Approach

DURATION: One day

AIM: To enhance and update knowledge and skills required to work with complex safeguarding issues.

TARGET GROUP Professionals with:

- Particular responsibilities in relation to undertaking Section 47 enquiries including professionals from health, education police and children's social care; those who work with complex cases and social work staff responsible for co-ordinating assessments of children in need. Group 4
- With professional advisers, designated, named and lead professionals Group 5
- Those who have completed the 2 Day Advanced or equivalent course within the past 2/3 years

This training aligns with: Level 4 & 5 (Safeguarding Children & Young People: Roles & Competences for Health Care Staff – Intercollegiate Document).

OUTCOMES:

By the end of the training session training participants will be able to:

- Help children and parents to learn how to notice when they are becoming mentally unwell and how to identify the triggers and alert others promptly
- Explored how mental illness can effect parenting capacity and the child's development
- Examine their own practice of assessing risk to children whose parents experience mental ill health
- Discuss how professionals from adult and children's services can work together to ensure the best outcomes for children affected by parental mental ill health
- Describe the referral pathway to alert agencies to deteriorating parental mental health and child safety /welfare concerns
- Describe and signpost to local and national support services are available for children and adults, including Early Help services

- describe the needs of children and young people from culturally and racially diverse backgrounds who are exposed to parents with substance misuse difficulties.

Working with Complexity & Risk (Engaging Hard to Reach Families)

Effective Practice in Working with Families where Children and Young People are living with Complex Neglect

- To use tools for analysis in working out what the child's lived experience is and to use a theoretical model to help practitioners work with parents to 'hold their children in mind'
- To develop ideas for creative plans that make a difference to children's lives and create change in families where neglect is present
- To set out the legal and procedural framework for responding to neglect with reference to the Bromley Thresholds document and the Bromley Neglect Strategy and Toolbox
- Understand and use the local referring pathways
- Understand and be able to apply early and effective intervention, assessment and support

Teenagers Self-Harming: Responding to Risk & Managing Professional Anxiety

OUTCOMES: By the end of the training session training participants will be able to:

- Explore how does self harm and self injurious behaviour manifest in children and adults
- Examine the impact of the covid pandemic and lockdown on levels of anxiety, depression and self-harm on children ,young people and adults.
- Identify the nature ,characteristic and prevalence of self harm and self injury among children, young people and adults
- To Identify the individuals and groups who are more at risk of self harming
- Have greater awareness of the factors and situations and hazards that are likely to be stressors and triggers to self harm
- Identify key risks associated with self harm, including the influence of gender, sexuality, age and other social factors
- Understand the experiences of children and young people who self harm and the impact on their emotional ,social and cognitive development.
- Understand some of the cultural, religious and social factors which contribute to the high rate of self harm and suicide among Asian girls and women
- Identify strategies and interventions for managing self harm and undertaking risk assessments in an inter-agency context.

Race, Culture and Spirituality : Improving practice with children and families from Black and minority ethnic communities

Child Protection Training for Bromley Early Years staff

These courses are for early years and out of school providers in Bromley. The content of these training courses meets the standards required by the Bromley Safeguarding Children Partnership (BSCP), the requirements from the Early Years Foundation Stage (EYFS) and Ofsted.

If you are unable to get a place on any of the courses, we recommend you complete the free child protection e-learning course available on the BSCP website, but you must book the next available place on the Bromley Early Years class based course.

The EYFS states that 'the lead person must attend a training course that enables them to identify, understand and respond appropriately to signs of possible abuse and neglect. **Taking advice from the local authority on appropriate training courses**'

The following courses for **childminders** and **designated leads** are the courses recommended by the local authority:

- **Child Protection for Designated Leads in pre-schools, day nurseries and out of school provision and for pre-school committee members.**
Delivered over two half days. Bromley Early Years Team recommends that all Designated Leads and at least one committee member (if applicable) attend this training.
- **Child Protection for Childminders.**
Delivered over two half days (usually evenings) or one full day (usually Saturday).
- **Child Protection Training for childminder assistants and practitioners in pre-schools, day nurseries and out of school provision.**
One half day sessions (usually afternoon or evening).
- **Introduction to child protection**
Half day session.

Attendance at any of the above courses is a pre-requisite for attending BSCP multi-agency training.

- **INSET days**
Half day or full day bespoke safeguarding training for your full staff team.
- **Workshop to Raise Awareness of Prevent (WRAP) includes *PREVENT in an EYFS setting*.**

The Early Years Team recommends all childminders and at least one person from each early years setting attends this course.

An Introduction To Speech, Language And Communication

ICAN's CPD online short course is **free** and a great place to start learning about children and young people's speech, language and communication development. It looks at how you can support the development of these skills on a day-to-day basis in your setting, and how to spot children and young people who might be struggling to develop these important skills.

We have re-developed this course so it is now tailored for the needs of practitioners working across all ages. You have the option to access four different pathways depending on the age of the children you predominantly work with – early years, primary, secondary or further education so you can choose which pathway is most relevant to your area of work.

If you work across more than one educational phase, you will only need to complete the phase which you predominately work in as the key principles are transferable across all the age ranges. **The course takes approximately 3 hours to complete.**

Why should I learn about speech, language and communications needs of children? Isn't that just for teachers and therapists to know?

The impact of speech and language needs is huge. Did you know...

10% of children have long-term and persistent SLCN.

Speech, language and communication skills are closely linked to behaviour. We need language to exercise self-control, follow rules and understand cause, effect and consequences, and deal with conflict.

60-90% of young offenders have poor communication skills.

Two thirds of children at risk of being excluded from school have language difficulties.

Good speech, language and communication skills are also very important in emotional wellbeing and good mental health. It affects confidence and self-esteem, resilience, empathy and an ability to understand and control emotions.

You need to do this course!

Once a number of practitioners have completed this course, we will follow up with some short webinars run by our [Bromley Speech and Language Therapy team from Bromley Healthcare](#) where you can ask questions and learn about local services and pathways to support.

Tackling Sexism and Sexual Harassment in Schools

UK Feminista's online training course equips school staff and trainee teachers with the knowledge, tools and confidence to challenge sexism and sexual harassment in the classroom.
